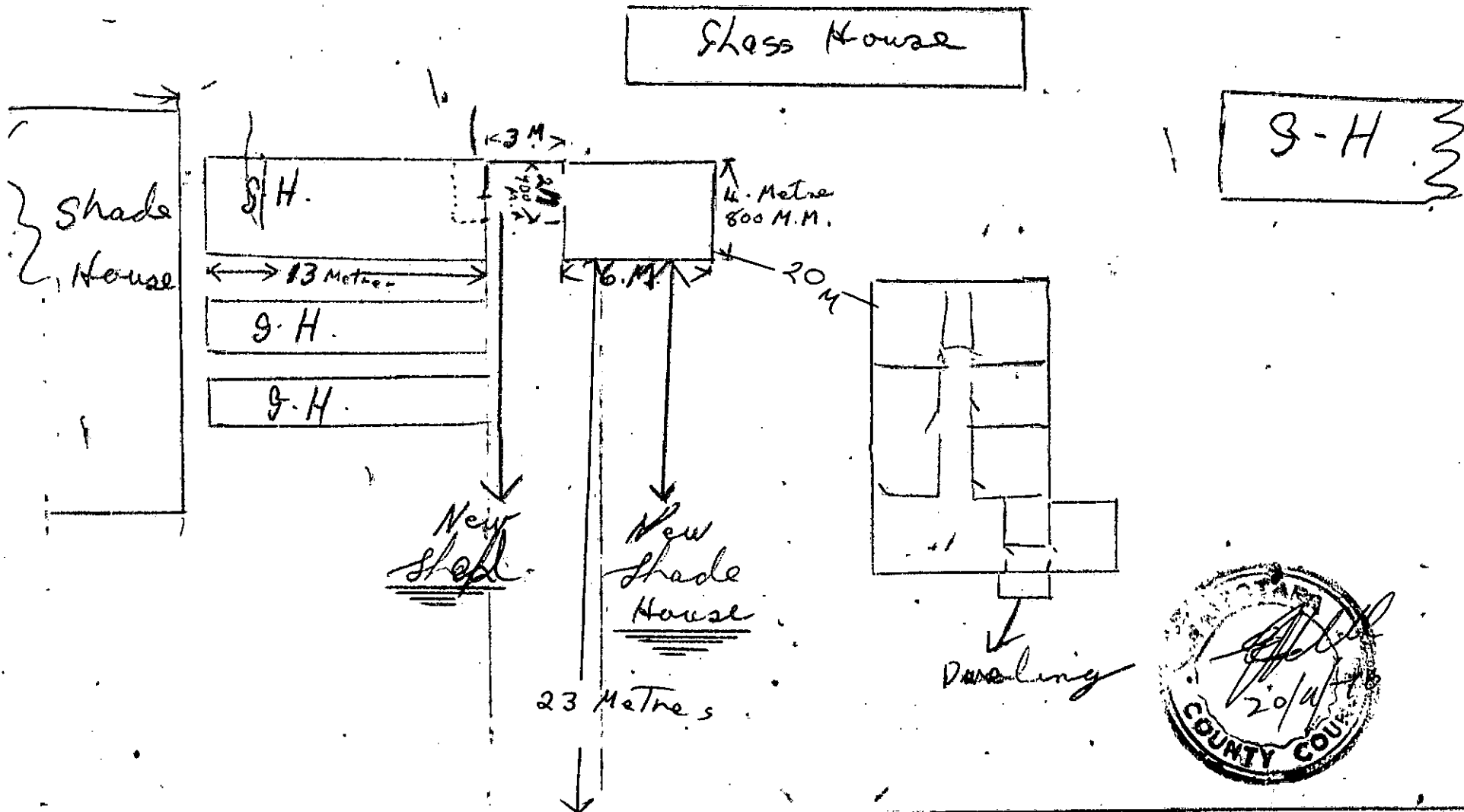

for R.H. Robottom Brunswick Rd. R.D.



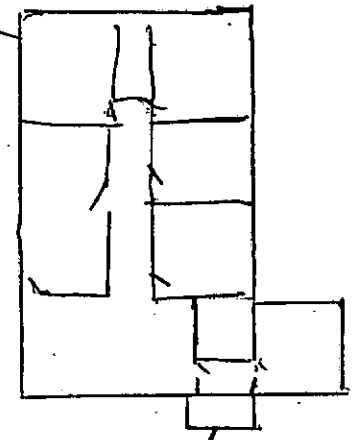
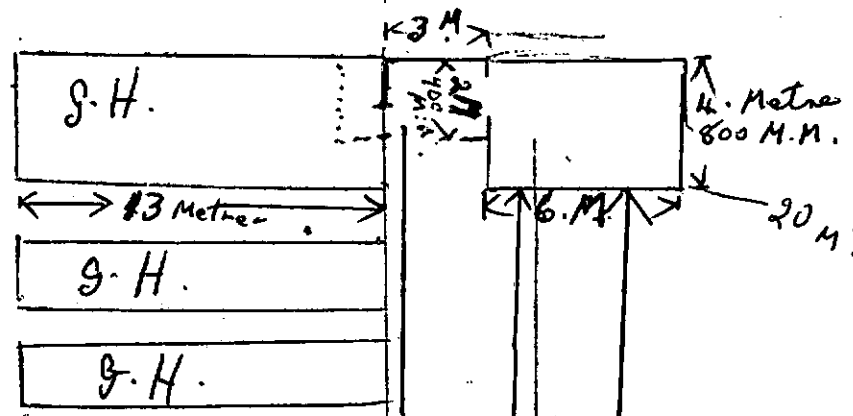

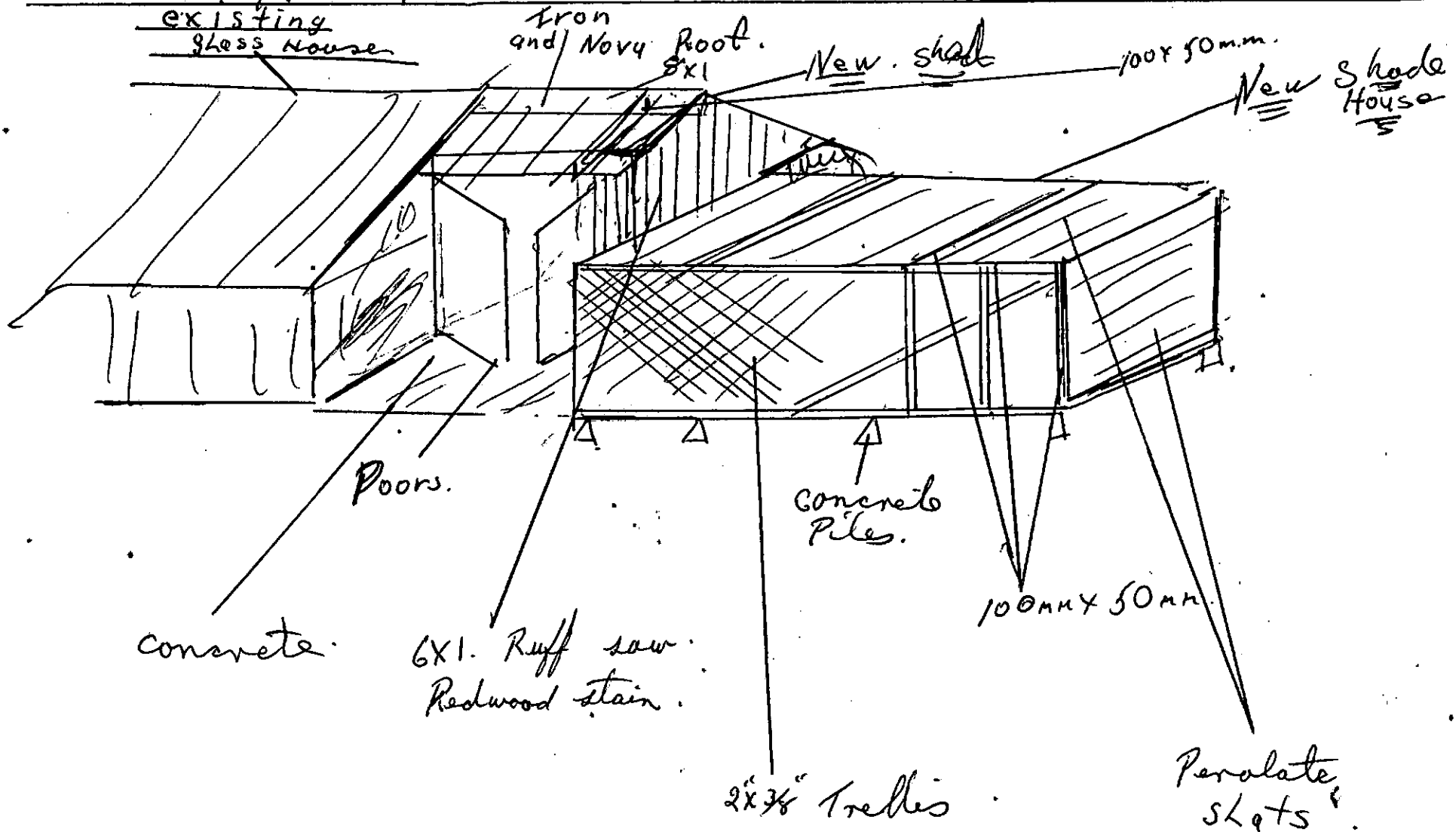
