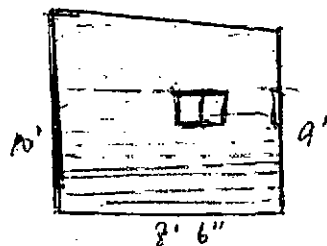
PROPOSED ADDITION TO RESIDENCE 153 CORNFORD ST.

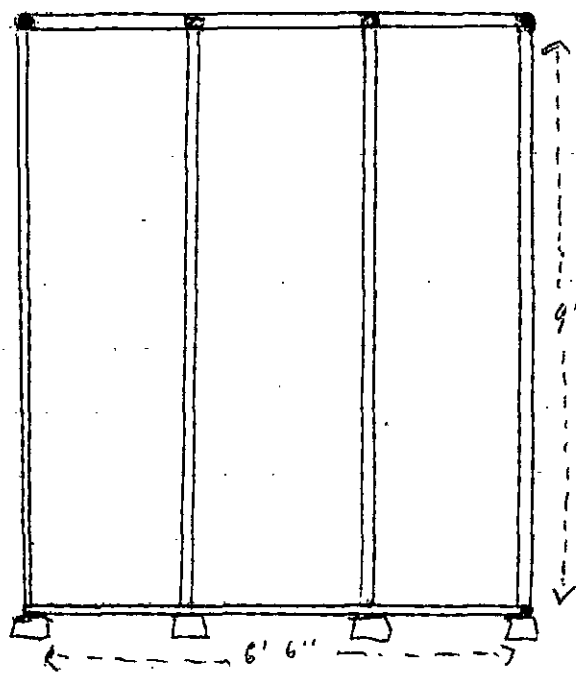
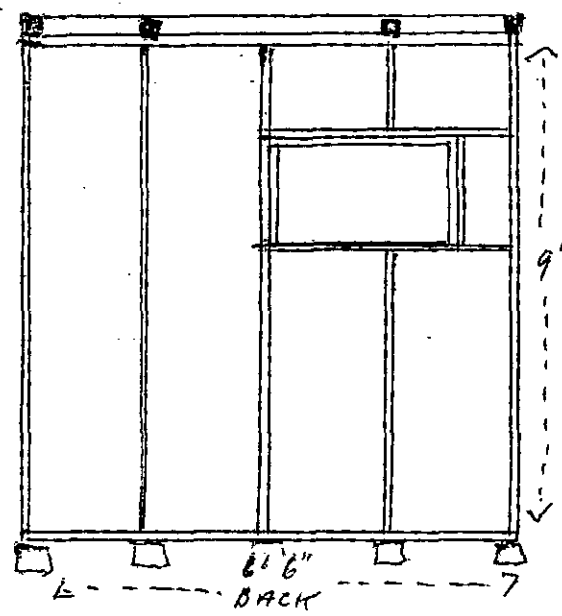
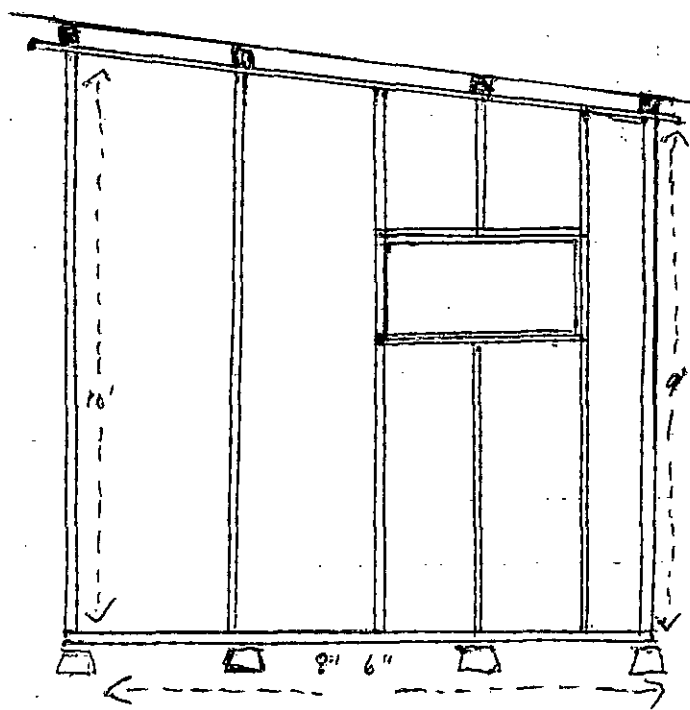


FRONT ELEVATION.
