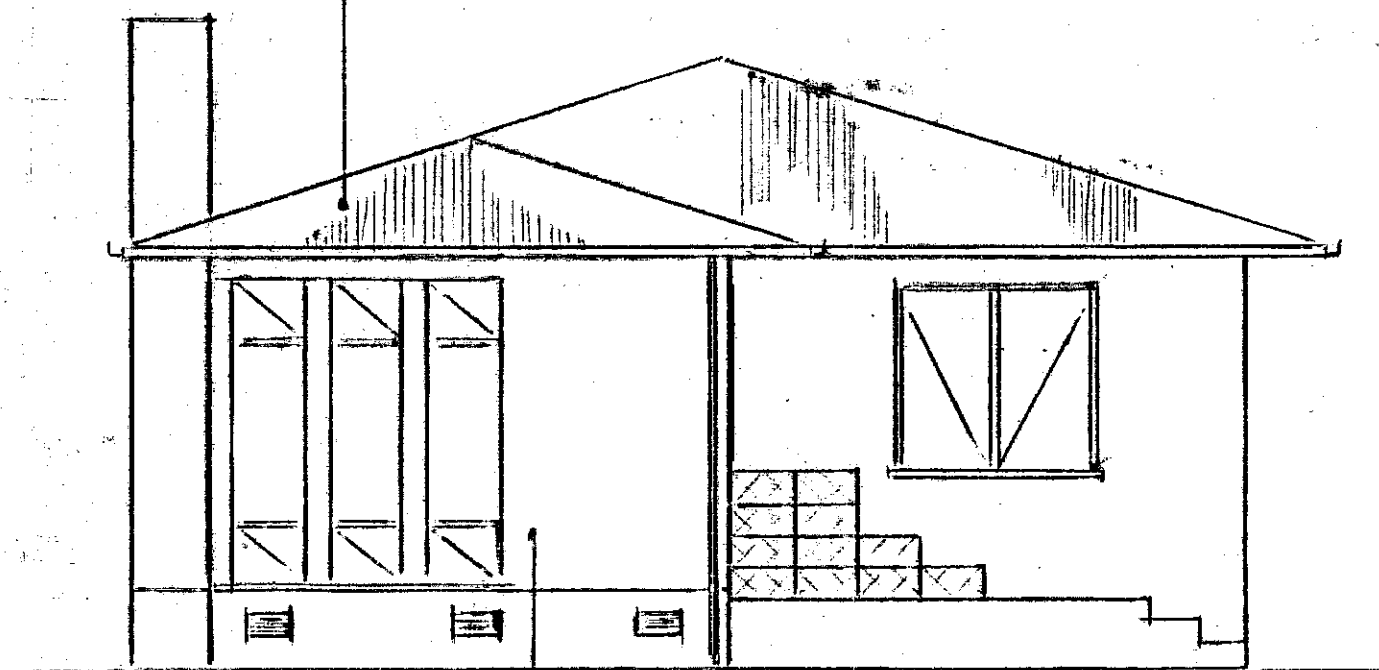

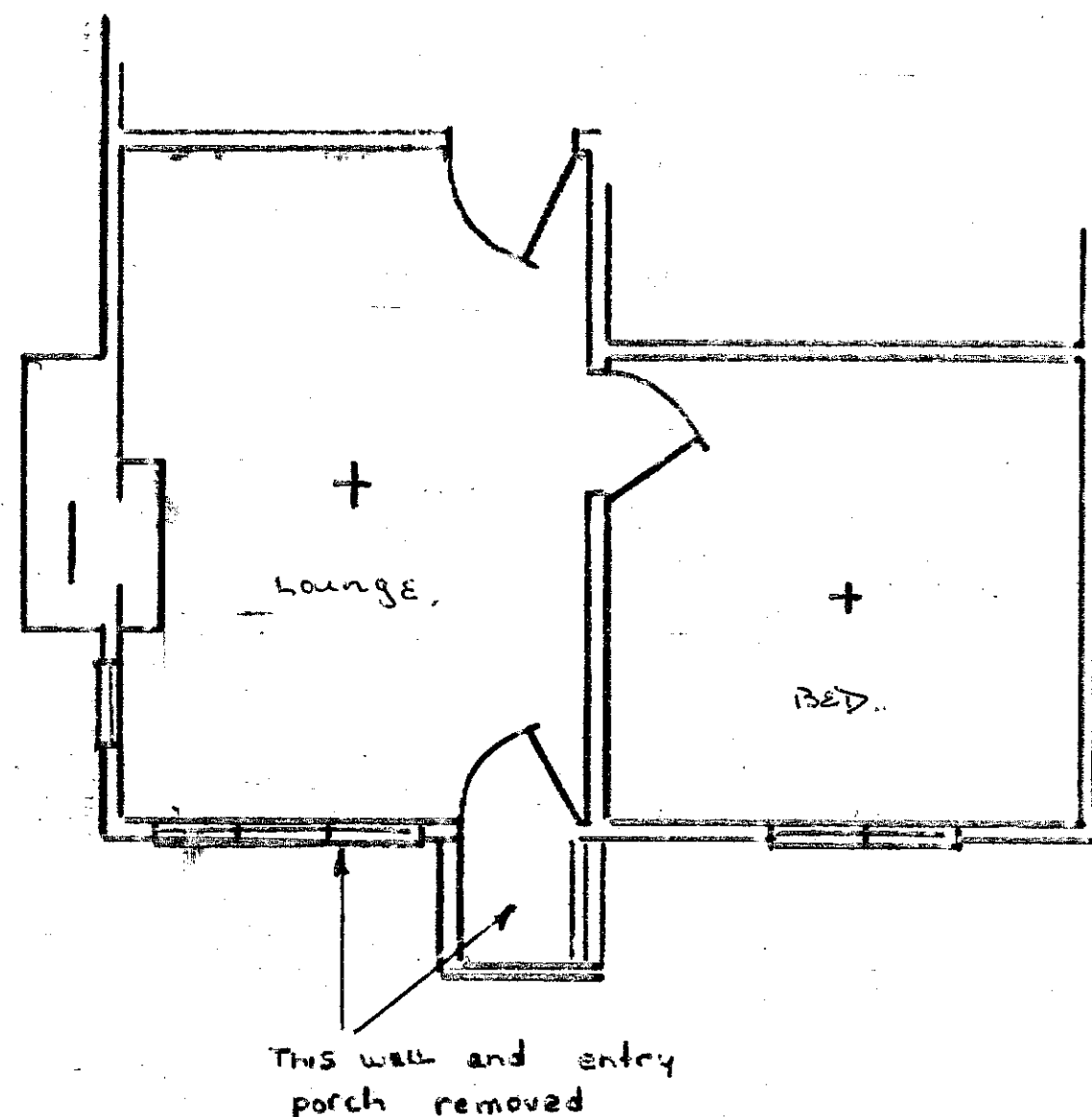
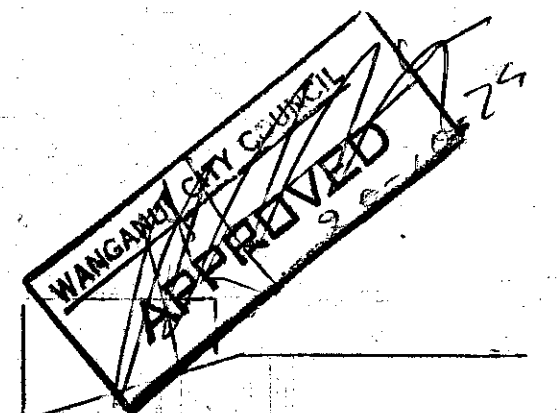
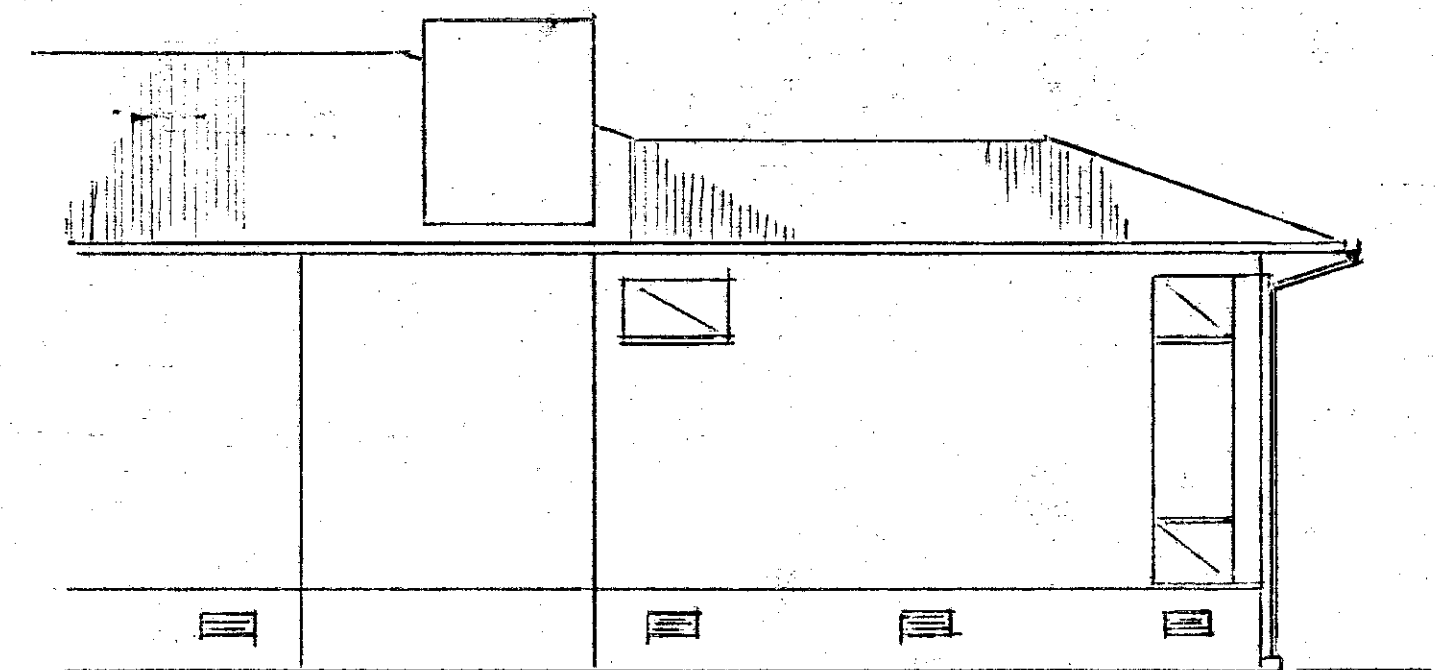
SITE &

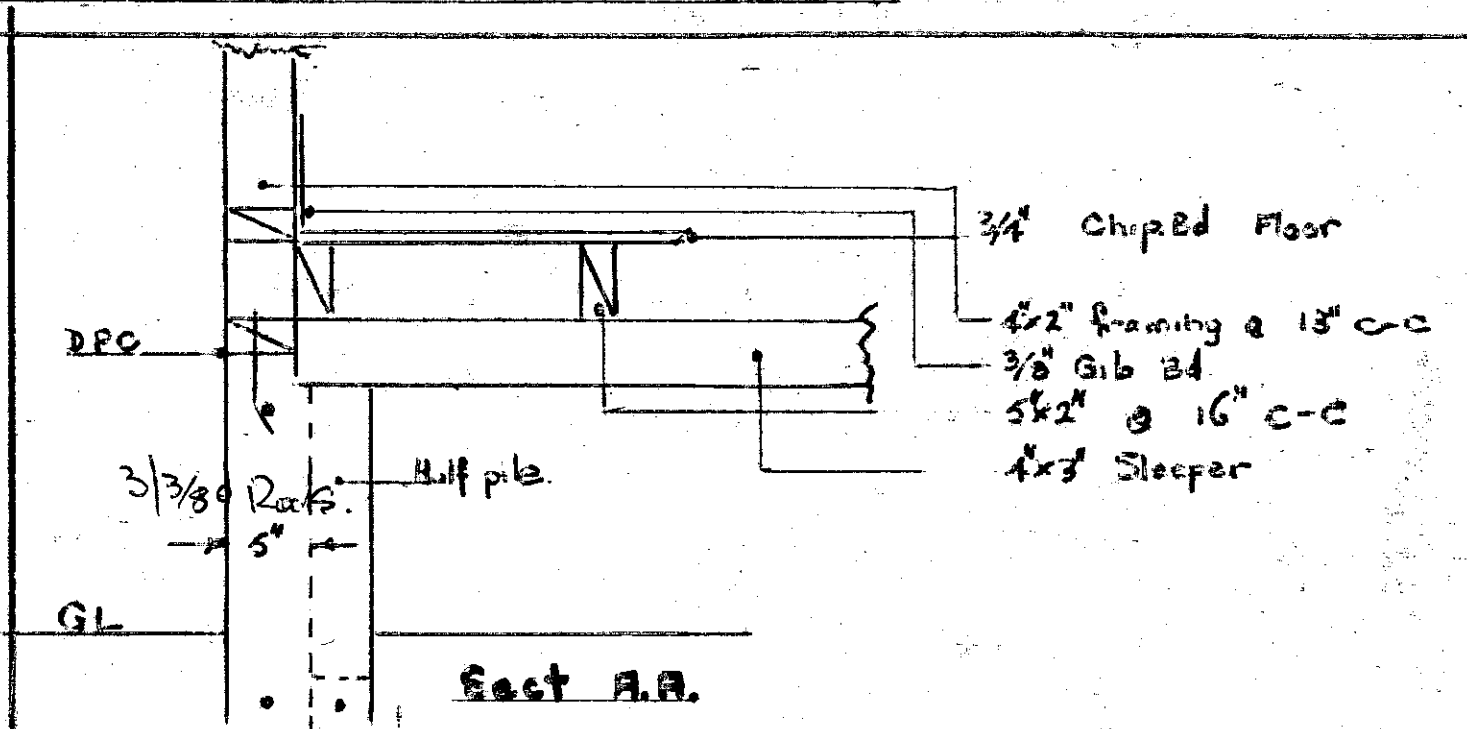
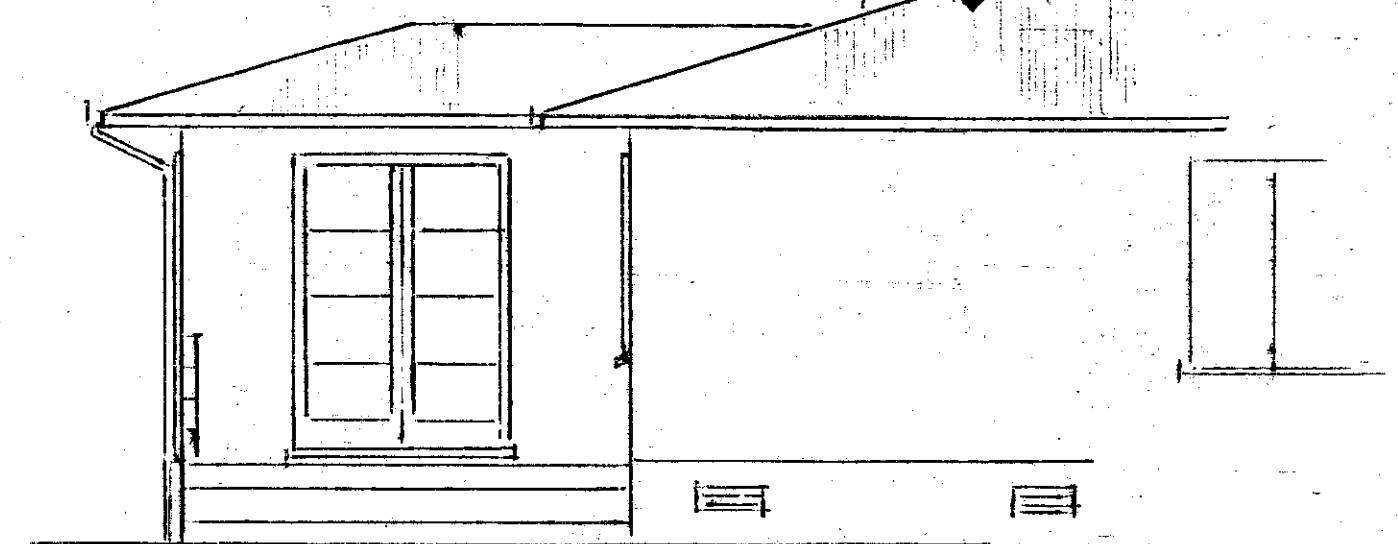
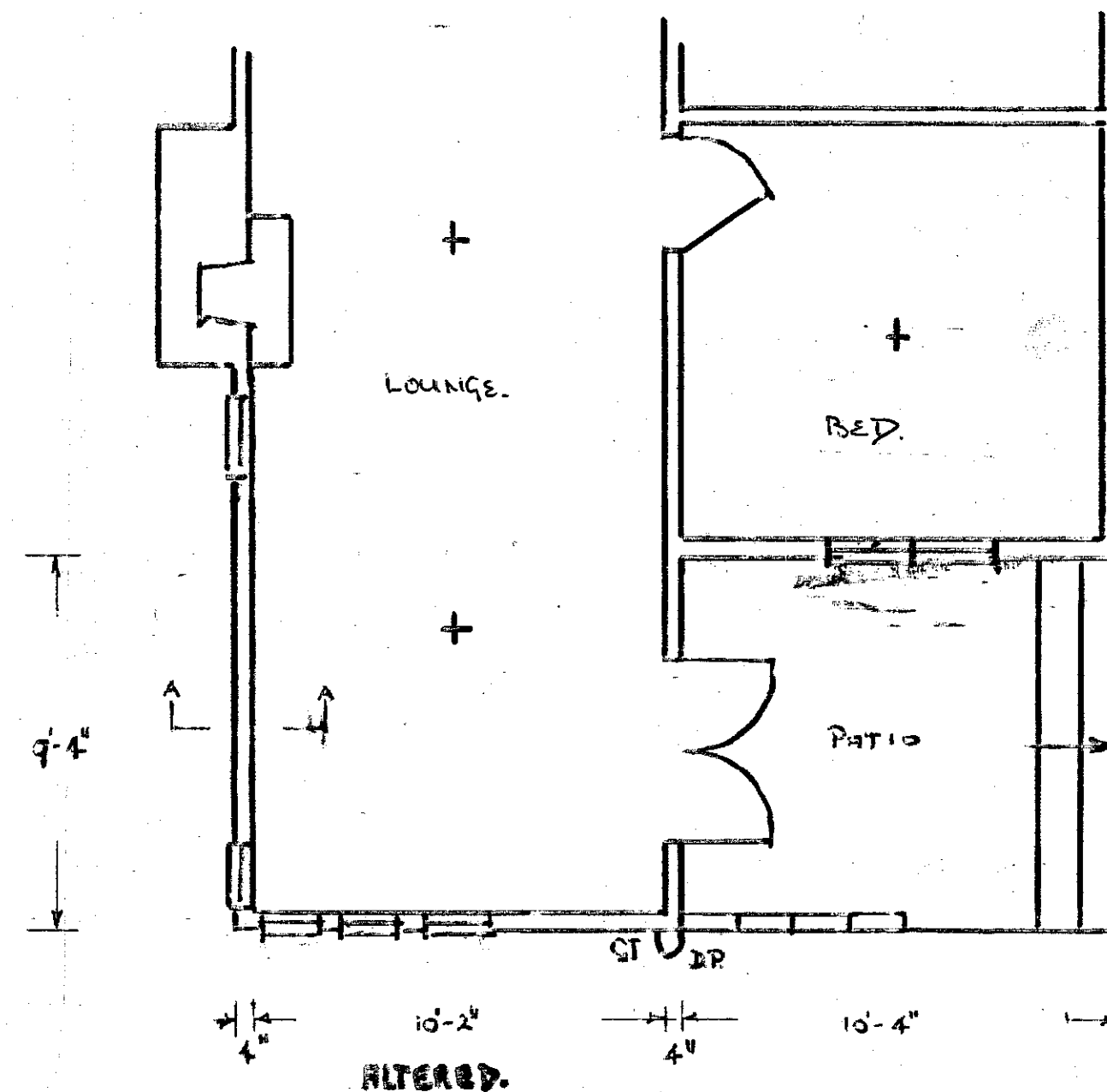
