 - (iv) Signs on building - - - \$2.00
 - (v) Sign painted on building - - - \$1.00
 - (vi) Temporary sign - - - \$0.25 per week
- (b) Fee for licence to erect hoarding - - - \$2.00
- (c) Annual licence fee for —
 - (i) Roof Sign:
15c per sq yd per annum with minimum fee of \$1.00.
 - (ii) Special Sign:
15c per sq yd per annum with minimum fee of \$1.00.

In any dispute, the Engineer shall have the absolute determination of the value of such work.
