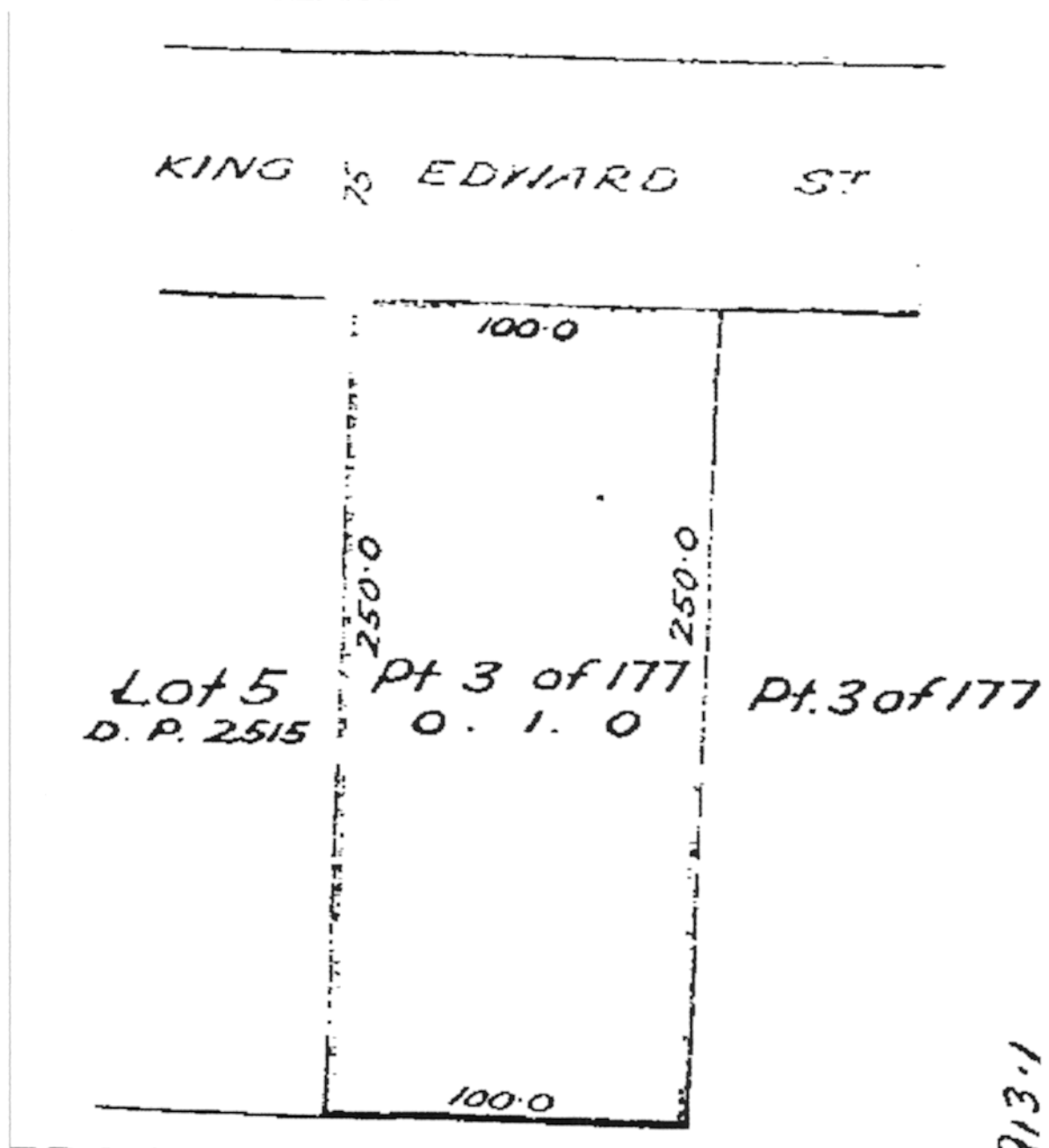

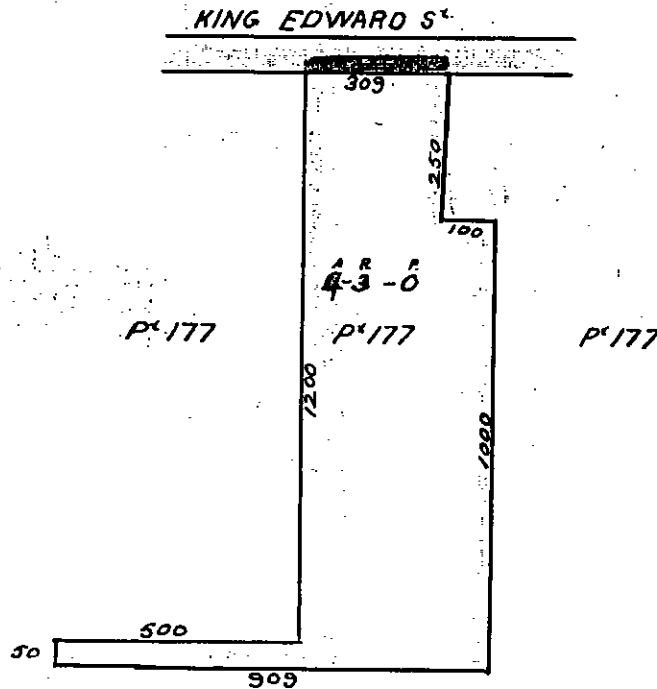

The Southern Side of Portion of King Edward Street, in the Borough of Motueka, exempted from the Provisions of Section 128 of the Public Works Act, 1928, subject to a Condition as to the Building-line.

GALWAY, Governor-General.

ORDER IN COUNCIL.

At the Government House at Wellington, this 24th day of February, 1937.

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

IN pursuance and exercise of the powers conferred by the Public Works Act, 1928, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolution passed by the Motueka Borough Council on the nineteenth day of January, one thousand nine hundred and thirty-seven, viz.:—

“That the Motueka Borough Council, being the local authority having control of the streets within the Borough of Motueka, hereby declares that the provisions of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to the southern half of King Edward Street fronting the northern boundary of part 177, Motueka Original District, Block III, Motueka Survey District”;

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the southern side of the portion of King Edward Street (described in the Schedule hereto) within a distance of thirty-five feet from the centre-line of the said portion of street.

SCHEDULE.

THE southern side of all that portion of street, situated in the Nelson Land District, Borough of Motueka, known as King Edward Street, fronting part Section 177, Motueka Original District, Block III, Motueka Survey District. As the same is more particularly delineated on the plan marked P.W.D. 94914, deposited in the office of the Minister of Public Works at Wellington, and thereon coloured red.
