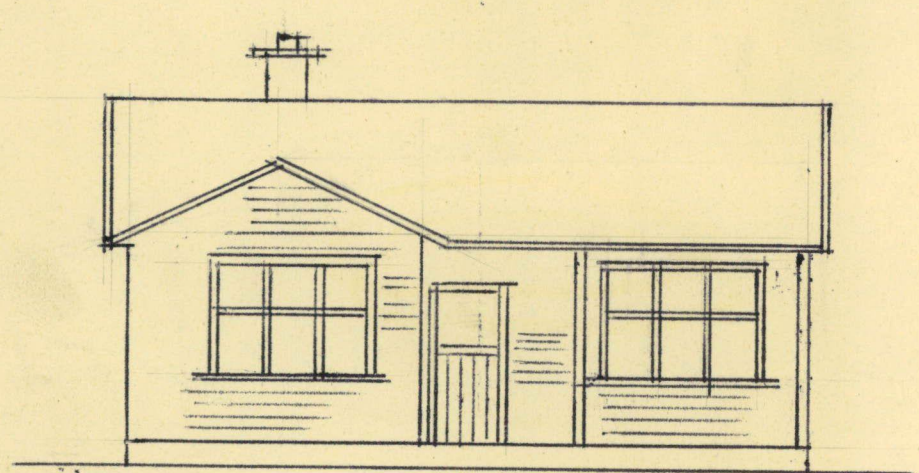


PROPOSED RESIDENCE FOR.
