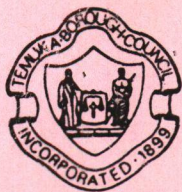

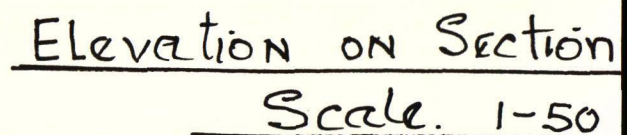
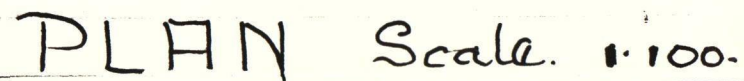
Please provide me with a plan of the existing drainage system. I understand that some of the drains may have been built over in the past and this may need to be remedied.

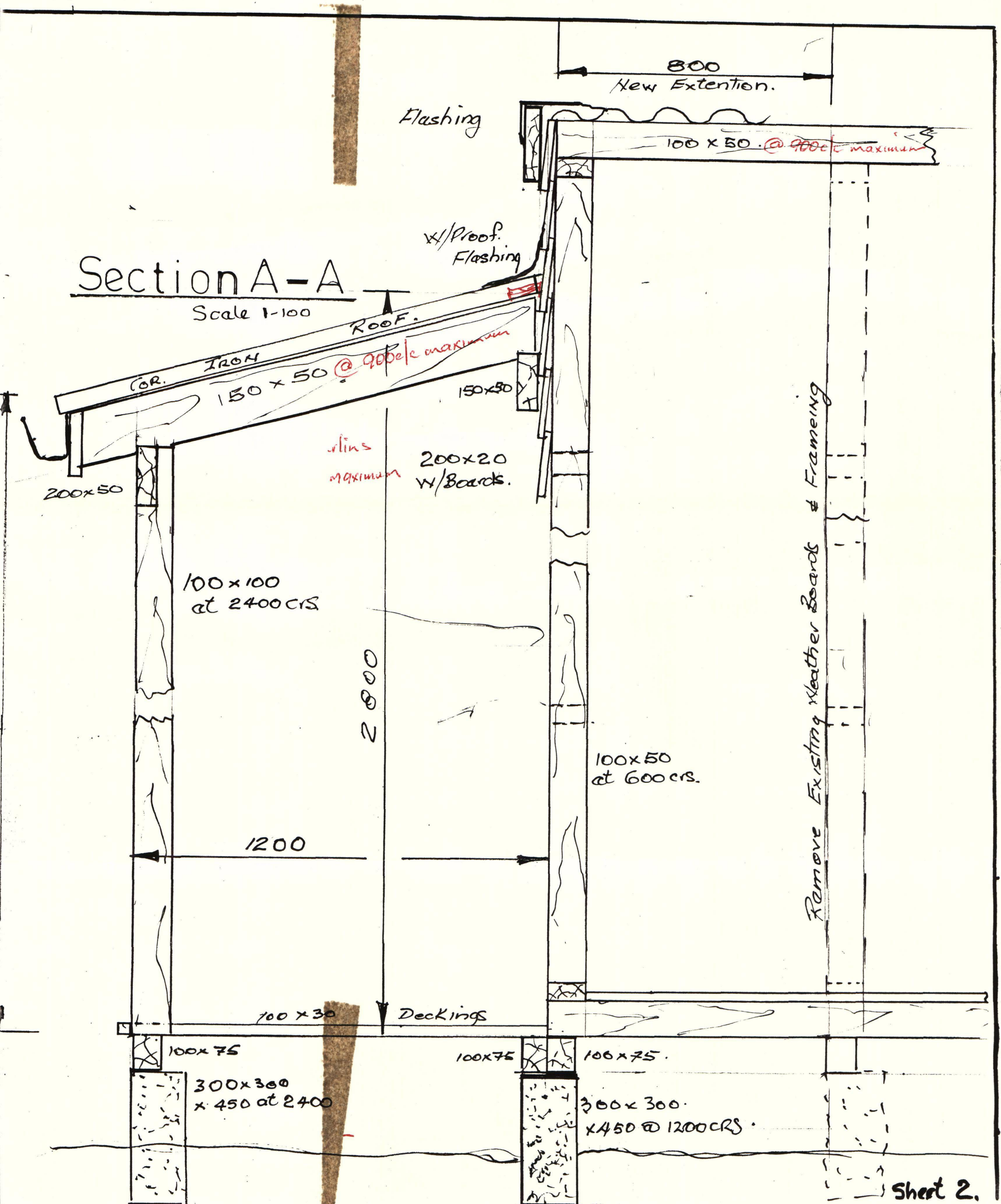

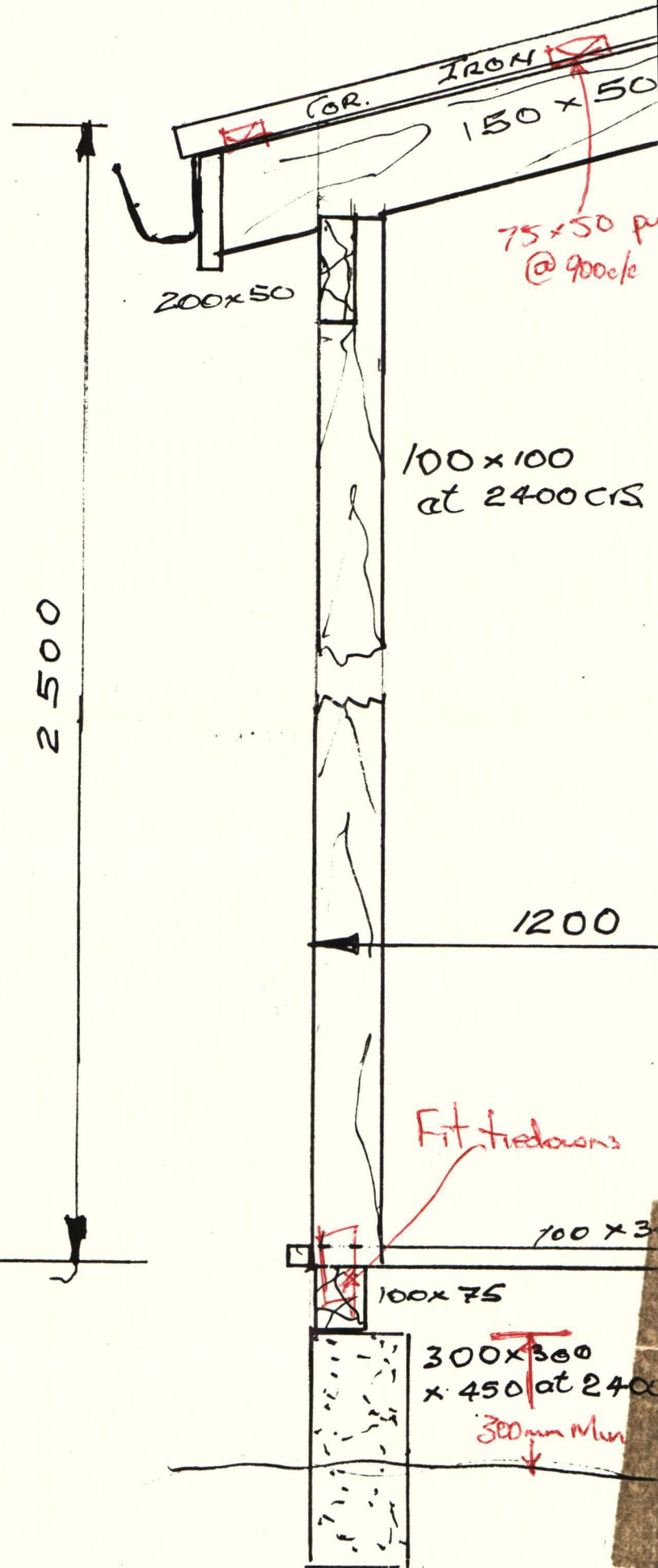

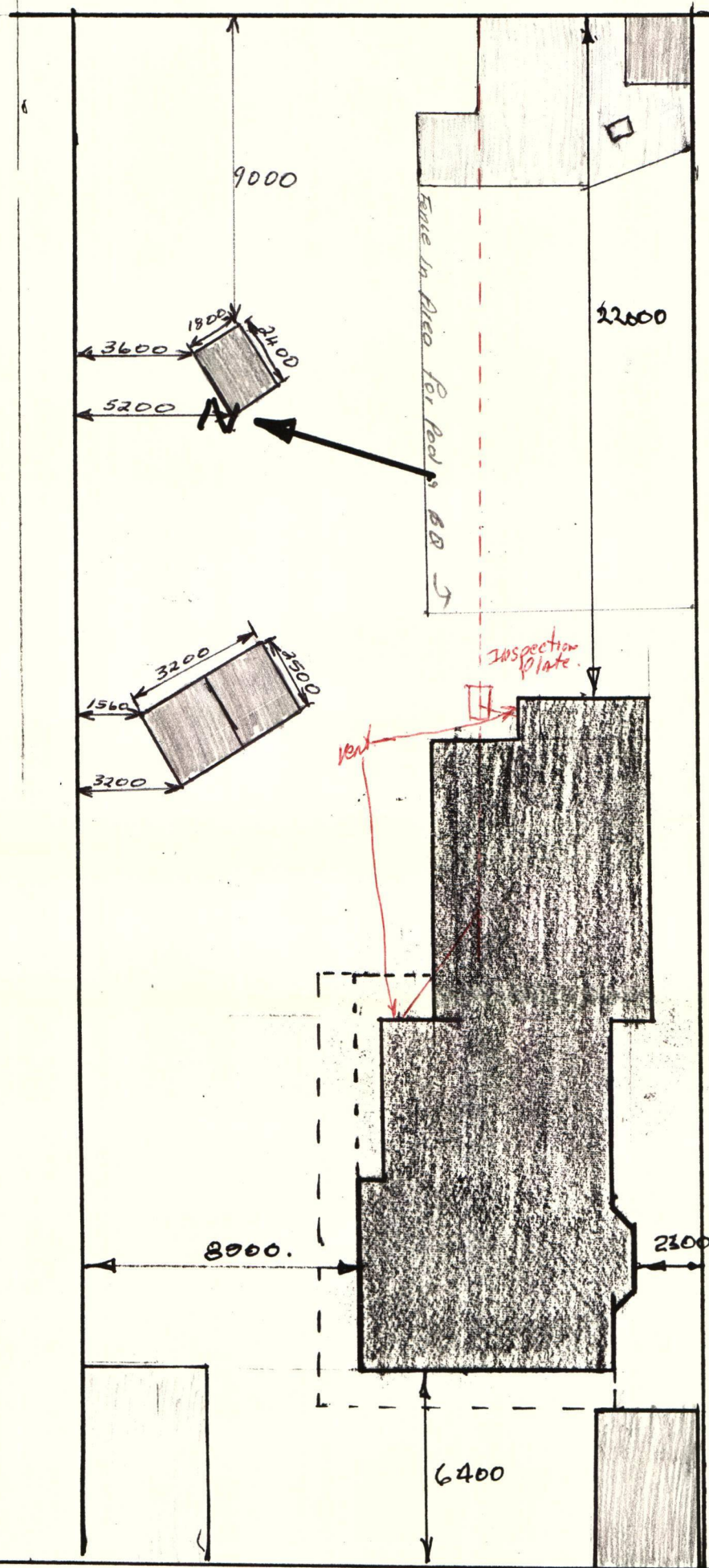
