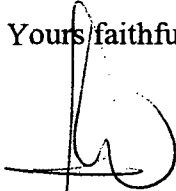

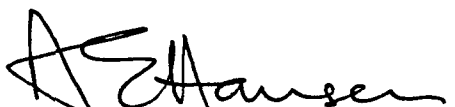
The Rotorua District Council hereby certifies that the following resolution was passed under delegated authority on the 9<sup>th</sup> of November 1998.

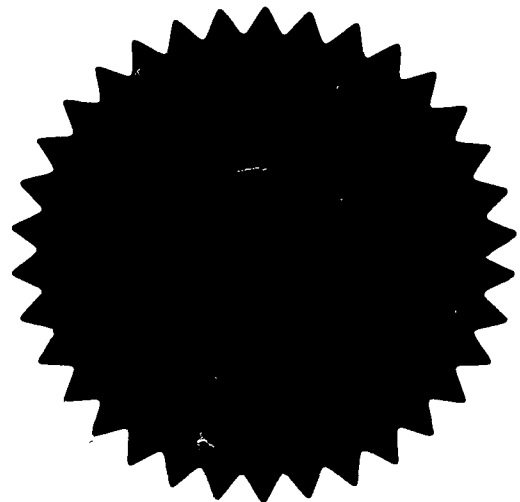

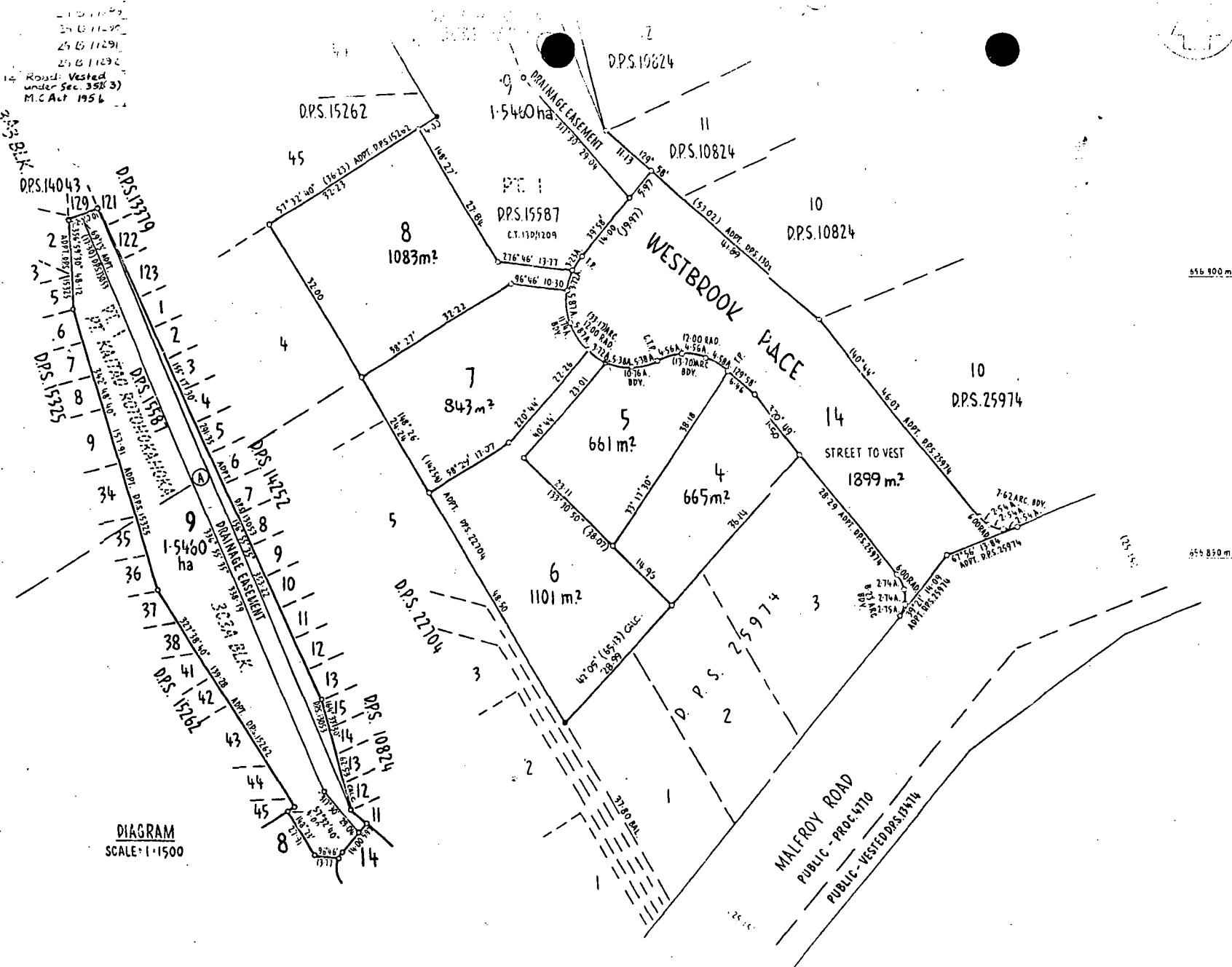
